1. **CALL TO ORDER**  
Committee Chair McQuary called the meeting to order at 9:30 a.m.
2. **ROLL CALL OF THE DEVELOPMENT COMMITTEE**  
Committee Chair McQuary reported that all members were present.

5. **VALLEY EXPRESS- (ACTION MAY BE TAKEN)**  
The Committee discussed the Valley Express service recommendations. The committee heard a presentation from Gregg Hart and Jim Kemp with Santa Barbara County Association of Governments (SBCAG). Following a discussion, Director Davis stated that the Development Committee supported the following comments:
  - MTD supports the Valley Express Reintegration Plan
  - Require that staff of MTD and SBCAG convene to define roles and responsibilities in providing regional transit to the MTD Service Area
  - That SBCAG staff recognize that new and/or expansion of public transit service requires consent of the MTD Board
